



NOTICE OF VOLLUNTARY DISMISSAL UNDER RULE 41(a)(1)(i)

NOW COMES the Plaintiffs, RASA MALKEVICIENE and VYTAUTAS MALKEVICIUS, by and through their attorney, AURELIUS BUTVILAS, and states as follows:
