**DEFENDANT'S MOTION FOR LEAVE TO  
FILE A REPLY MEMORANDUM IN EXCESS OF FIFTEEN PAGES**

NOW COMES the Defendant, BARRY S. MARAM, in his official capacity as Director of the Illinois Department of Public Aid, by and through his attorney, LISA MADIGAN, Attorney General for the State of Illinois, and hereby seeks leave of the Court to file a Reply Memorandum in support of the Defendant's Motion to Dismiss Plaintiffs' Amended Complaint, stating as follows:

1. Plaintiffs' Amended Complaint seek prospective injunctive relief for alleged violations of Title XIX of the Social Security Act, Title II of the Americans with Disabilities Act, and Section 504 of the Rehabilitation Act of 1973.

2. Defendant has filed a Motion to Dismiss the Plaintiffs' Amended Complaint pursuant to Rule 12(b)(6) of the Federal Rules of Civil Procedure for failure to state a claim upon which relief can be granted. The Defendant filed a Memorandum of Law in Support of the
